



## Spin Golf Rules

**Spin Golf Pty Limited A.C.N. 601 968 610 (the “Company”) owns *Spin Golf* and conducts *Spin Golf Competitions*.**

Words appearing in *italics* and how this document is to be interpreted are as defined and provided for in the *Spin Golf Terms and Conditions*, which can be found on the *Spin Golf Website*. They apply to and are legally binding for every *Spin Golf Competitor* and it is important for them to read and understand them.

### Background

*Spin Golf* has been created for golfers who play in real *Competitions* and hold a valid *Golf Link Handicap*.

It has the purpose of incentivising golfers to play more golf and to be rightfully rewarded for playing a great round of golf. *Spin Golf* aims to vigorously promote the game of golf and increase participation in amateur golf competitions at the local club level, whilst also connecting Australians through a shared passion.

Through each and every *Spin Golf Competition*, the game of golf and all involved in the Australian golf industry benefit.

### 1. Spin Golf Competitions

1.1 The A *Spin Golf Competition* is a *Competition* for *Amateur Competitor’s* whereby their *Points* are compared against other *Spin Golf Competitor’s Points* in their relevant *Pool*.

1.2 Each *Spin Golf Competitor* will be ranked within their *Pool* based on their *Points* for the purpose of determining prizes. Within the *Competition Period* the *Company* will use the *Spin Golf Competitor’s* round that has the most *Points* for ranking purposes.

### 2. Entry

2.1 This may only be done via the *Spin Golf Website*. Upon entering, each *Spin Golf Competitor* will enter into a legally binding *Contract* with the *Company* in accordance with the *Terms and Conditions*.

2.2 Only persons who are over 18 years may enter and become *Spin Golf Competitors*.

2.3 Subject to *Spin Golf Rule 2.5* below, golfers who enter the *Spin Golf Competition* and pay their *Entry* fee in the manner described below will become a *Spin Golf Competitor* and be eligible to compete in a *Spin Golf Competition*.

2.4 Each valid *Spin Golf Competitor* will have each of his/her *Scores* gained within the *Competition Period* converted to *Points*. The *Score* that results in the highest number of *Points* will be used to rank the *Spin Golf Competitor* against other *Spin Golf Competitors* in the same *Pool*.

2.5 Only golfers whose results for a *Competition* are recorded and published by *GOLF Link* by 11:59 pm EST on the second day after the final day of the *Competition Period* (“the *Results Cut off Time*”) will be deemed to have entered the *Competition* and be accepted as *Spin Golf Competitors* in the *Spin Golf Competition*. This rule is necessary to enable the *Company* to calculate *Prize Pools* and record prizes won. The *Company* will use all reasonable endeavours to calculate the *Prize Pool* on the third day after the final day of each *Competition Period*.

2.6 Where a *Spin Golf Competitor’s* results are not recorded and published before the *Results Cut off Time*, their entry fee will be applied, but subject to the same requirement as provided for in *Spin Golf Rule 2.5*, to the next *Spin Golf Competition* in which he / she plays.

### **3. Entry Fees**

3.1 Entry fees for all *Spin Golf Competitions* must be paid by credit or debit card, PayPal or any other approved method (“*Payment Method*”) in advance and in accordance with paragraphs 3.2 to 3.5 (below).

3.2 On entry payment of the selected *Entry Option* the *Spin Golf Competitor* will be able to enter as many *Spin Golf Competitions* that the nominated *Entry Option* permits (as detailed in the *Terms and Conditions*). For the avoidance of doubt, the *Spin Golf Competitor* may only enter one *Spin Golf Competition* per week, regardless of the *Entry Option* they have paid for.

3.3 If a *Spin Golf Competitor* has opted for payment of their selected *Entry Option* via *Auto Renew*, the *Spin Golf Competitor’s* credit or debit card will be charged the full amount of that *Entry Option* upon exhausting all entries in order to ensure the *Competitor’s Account* always has a valid entry into a *Spin Golf Competition* (subject to payments being appropriately processed and authorised). If the payment cannot be processed due to a payment error or other error, *Spin Golf* will notify the *Spin Golf Competitor* and until such time as the *Entry Option* has been paid in full, the *Spin Golf Competitor* will be deemed to not have an active entry for the relevant *Spin Golf Competition*.

3.4 Entry fees must be processed, authorised and paid before 7:00 am EST on the day of the *Spin Golf Competition* that an eligible *Spin Golf Competitor* is registered to play (“*Entry Fee Cut off Time*”). Any entry fee for a *Spin Golf Competition* that cannot

for any reason be successfully charged to a *Spin Golf Competitor's Payment Method* before the *Entry Fee Cut off Time* will apply to the next *Competition* that the *Spin Golf Competitor* plays.

3.5 *Spin Golf Competitors* are able to play in multiple *Competitions* in any given day or week as the *Spin Golf Competitor* would like, however the *Company* will only use the *Score*, which has resulted in the highest amount of *Points* for the *Spin Golf Competition*.

#### **4. Winning in a *Spin Golf Competition***

4.1 To win a prize in a *Spin Golf Competition* the *Company* will:

- 1) look at each *Competition* played by a *Spin Golf Competitor* within the *Competition Period*;
- 2) take the *Score* with the highest number of *Points*; and
- 3) rank that score against other *Spin Golf Competitor's* in the same *Pool*.

Subject to the size of the *Pool*, prizes will be distributed to the top 10 places [only]. For more information see *Spin Golf Rule 7 "Prizes"* for more details.

4.2 All *Spin Golf Competitors* must provide their *GOLF Link Number* to the *Company* when entering a *Spin Golf Competition* for the sole purpose of enabling the *Company* to access and use their *GOLF Link* handicap history record to ascertain their *Daily Handicap* and *Played To* details and result for the *Competitions* played within a *Competition Period*.

4.3 Each *Spin Golf Competitor*, by entering a *Spin Golf Competition*, irrevocably authorises the *Company* to access and use their *GOLF Link* handicap history record for the above purposes.

4.4 Each *Spin Golf Competitor*, by entering *Spin Golf*, irrevocably authorises and consents to *GA* and *GLP* divulging their *GOLF Link* handicap history record for the above purposes.

4.5 *The Company* must not access or use any other personal information of a *Spin Golf Competitor* that is recorded on *GOLF Link* without the written consent of the *Spin Golf Competitor*.

#### **5. Eligibility**

5.1 *Competitors* are eligible to enter and play in a *Spin Golf Competition*.

5.2 Professional golfers are ineligible.

## 6. Motorised Transport

6.1 *Spin Golf Competitors* are permitted to ride on any form of transportation when playing in a *Spin Golf Competition*, provided that they are authorised to do so in the *Competition* in which they are also simultaneously playing.

## 7. Prizes

7.1 At the close of each *Competition Period* a *Prize Pool* will be established for each *Pool*.

7.3 Prizes will be distributed as *Credits* and not cash. *Credits* can be used on the *Spin Golf Website* to purchase gift vouchers, golf equipment or entries into *Spin Golf Competitions*. One (1) *Credit* has a nominal value of one (1) Australian (\$) dollar.

7.4 All individual prize winnings of 200 *Credits* or more will have 20% of that prize winnings allocated to be spent at any Australian Golf Club. The remaining prize money may be spent in any form as noted in rule 7.3 above. To further clarify, if a player wins 250 *Credits*, they will be able to use 200 *Credits* (80% of prize winnings) on any item on the *Spin Golf Website* and the remaining 50 *Credits* (20% of prize winnings) must be spent at any Australian Golf Club.

7.5 Rule 7.4 above does not apply to accrued prize balances over time which may exceed 200 *Credits*. These balances can be used in any form as specified in rule 7.3 above.

7.6 The prize values will be recorded in the *Competitor's Account* as *Credits*. This account is the running account kept by the *Company* on the *Spin Golf Website* and available to be accessed only by each individual *Spin Golf Competitor* using their unique password.

## 8. Maximum Prizes

8.1 The maximum amount of winnings that are given out to each winner in a *Spin Golf Competition* is as follows:

### Silver Entry

- 1<sup>st</sup> Place - \$500
- 2<sup>nd</sup> Place - \$300
- 3<sup>rd</sup> Place - \$150
- 4<sup>th</sup> to 10<sup>th</sup> Place - \$50 each

### Gold Entry

- 1<sup>st</sup> Place - \$1,000
- 2<sup>nd</sup> Place - \$600
- 3<sup>rd</sup> Place - \$300

- 4<sup>th</sup> to 10<sup>th</sup> Place - \$50 each

Each *Spin Golf Competitor* must understand and abide by the Amateur Status rule as outlined in *Spin Golf Rule 11* below.

## 9. Minimum and Indicative Prizes

9.1 A minimum prize value of \$20 will be awarded to any winner in a *Spin Golf Competition*. A sample table of indicative prizes is given below:

Sample Prizes Table

Players	Prizes Awarded	Silver Entry – 1 <sup>st</sup> Prize	Gold Entry – 1 <sup>st</sup> Prize
50	1 <sup>st</sup> – 3 <sup>rd</sup>	\$100	\$200
100	1 <sup>st</sup> – 5 <sup>th</sup>	\$150	\$300
200	1 <sup>st</sup> – 8 <sup>th</sup>	\$300	\$600
300	1 <sup>st</sup> – 10 <sup>th</sup>	\$500	\$1,000

It is important to note that actual prizes awarded depend on the number and type of entries for each *Pool* and final prize values will be determined at the end of each *Competition Period*.

## 10. Did Not Finish For Good Reason

10.1 If the result of a *Spin Golf Competitor* who has played in a *Competition* is recorded on his / her *GOLF Link* handicap history as “Did Not Finish for Good Reason” in that *Competition* he / she will be deemed not to have had a valid *Competition* round for entry to a *Spin Golf Competition* held that day and his / her entry fee will be applied (but subject to the same requirement as provided for in *Spin Golf Rule 2.5*), to the next *Competition* in which he / she plays.

## 11 Amateur Status

11.1 The \$1,200 amateur status total prize value limit as specified in the *Rules of Golf* applies to each *Spin Golf Competition* and the *Competition* in which the *Spin Golf Competitor* will simultaneously play. Accordingly the total value of all prizes won from these *Competitions* including the *Spin Golf Competition*, and any series of *Competitions*, is aggregated.

11.2 Every *Spin Golf Competitor* acknowledges that all *Spin Golf Competitors* are personally responsible for ensuring that they do not accept prizes that have an aggregate value in excess of the amateur status prize value limit and if they do win prizes in excess of this limit and they wish to retain their status as an amateur golfer, they will have to decline one or part of the prizes they win.

11.3 A *Spin Golf Competitor* must immediately notify the *Company* if he/she wishes to decline a prize won in a *Spin Golf Competition*.

## **12. Prize Vouchers and Redemptions**

12.1 Details of prizes won and a running account of the total value of *Credits* available for redemption and/or previously redeemed will be recorded for each *Spin Golf Competitor* on their *Competitor's Account* on the *Spin Golf Website*.

12.2 Each *Spin Golf Competitor* will have a unique password to access their *Competitor's Account*. This password should not be disclosed to any other individual or company and shall remain confidential at all times.

12.3 *Credits* won in a *Spin Golf Competition* can only be redeemed through the *Spin Golf Website*. Redemptions will be provided by way of:

- a) Gift vouchers or reward cards ("Vouchers"), which can be used at any retailer, service provider or *GOLF Link Affiliated Club* listed on the *Spin Golf Website*. Vouchers will be emailed to the email address of each *Spin Golf Competitor* as provided to the *Company* at the time of purchase.
- b) Golf equipment as listed on the *Spin Golf Website*. All golf equipment will be shipped to the *Spin Golf Competitor's* delivery address as detailed on the *My Account* section or as provided at the checkout section of purchasing.
- c) Purchase of *Spin Golf Entries*. Details of this purchase will be emailed to the email address of each *Spin Golf Competitor*, which is provided to the *Company* at the time of purchase

12.4 Under no circumstances will prize winnings be redeemed for cash.

12.5 Prizes winnings must be redeemed within one (1) year from the date they are won.
